The district received a \$25,000 PPCD grant toward the purchase of bag scanners for both middle schools and an additional scanner for the high school, student parking lot entrance.

As part of Act 44 the district is preparing to roll out the new Safe2Say Something program in January. The Safe2Say Something Anonymous Reporting System allows individuals to submit secure and anonymous safety concerns to help identify and intervene when unsafe and/or harmful behaviors take place. The tips can be submitted via the app, online, or a dedicated hotline, and each tip is reviewed by the call center housed in the Office of Attorney General. The call center will process and refer each tip to the appropriate school teams and law enforcement according to the level of threat.
