## **DEBT RESOLUTION**

A motion was made by Plisko second by Howard to adopt Debt Resolution authorizing the issuance of a tax and revenue anticipation note in an amount not to exceed \$6,000,000.00 to PNC Bank pursuant to its Proposal, with an origination fee of 0.20%, and an interest rate of 70% of Daily LIBOR + 1.25% floating, tax exempt, bank qualified. The purpose of the borrowing is to meet expenditures which presently remain unfunded as a result of the State budget impasse. The appropriate officers of the School District, Solicitor, and Administration are directed to execute all documents necessary to accomplish the borrowing should the same become necessary for fiscal year 2015-2016.

All members present voting in favor of the motion.

Controller Denise Sheetz stated there will be no cost to the district if we do not close. This resolution is being approved in case the budget does not pass or the funds are slow in coming.

#### CORRESPONDENCE

Mr. Bezjak announced notification was received from Connie Derr, Pennsylvania Department of Education Audit Coordinator that the single Audit Report for year ending June 30, 2014 is approved as being substantially in compliance with the OMB Circular A-133 and other relevant federal and Commonwealth policy.

Mr. Bezjak also announced a thank you was received from Smithfield Librarian Jean Kennedy for the continued monetary support. The funds will be used to start a new program called "Play K" geared for students attending kindergarten in the fall.
