FIRSTNET PROGRAM - SMARTPHONES

A motion was made by Planiczka second by Franks to approve the purchase of District smartphones to be used by principals and administrators from AT&T through the FirstNet program at a cost of \$.99 per device. Monthly charge is \$39.99/ea for unlimited talk/text/data. AT&T will provide a \$200 credit for each device purchased through the program. The District will also migrate all current Verizon phones to this program. Pricing is CoStars approved and to be paid using grant funding. All members voting in favor of motion.

AIRCARDS

Dunham to approve the purchase of 75 aircards to be given to students/families in need of internet connection for educational purposes from AT&T through the FirstNet program. The devices are free to the District with a monthly charge of \$36.99/ea for unlimited data. Pricing is CoStars approved and to be paid using grant funding. All members voting in favor of motion.
