# **PUBLIC FORUM**

High School Senior Luke Dice spoke on the GPA/Scholarship funding. Luke believes that students taking the Dual Enrollment courses should have those grades factored into their GPA to a total weight of 5.0. Pennsylvania students are at a disadvantage when applying to colleges across the country because they are not given credit for the college classes taken. He would like the board to consider revising the policy.

Dawn Dice, mother of Luke also spoke on the unfairness of the dual enrollment classes not being counted in students GPA. Students going to Tech for a trade are given credit or students who are enrolled in the work study program are given credit. Albert Gallatin policies need to be looked at and changed so all students are treated fairly.

President M. Dunham assured Luke and Mrs. Dice they will look into this and make corrections if needed.

The following students were honored and given a certificate of accomplishment for placing the Fayette County Firemen Essay Contest: Grade 5 Kassie Riderick, Alexia Swisshelm Grade 6 and, Clayton Watson Grade 7, Sarah Johnson Grade 6. Also given an award for her participation in the VFW Essay Contest was Trista Harrold Grade 7 and she now advances to the District Level. Congratulations to these students for a job well done.

Mrs. Swaney voices her dismay with the Harrisburg officials in not passing a state budget. They should be ashamed and embarrassed. They have cost all districts extra money because of the interest they have to repay when borrowing money to keep school in operation. Albert Gallatin had to repay an additional \$23,000.00 in interest. Six months and no budget is a disgrace, it is time for compromise by all concerned.

Mr. Bezjak agrees that the \$23,000.00 could have been better spent of books and supplies for our students. There is no end in sight and politics is the cause of the hardships, not only school districts are suffering from but other agencies as well. It is time to pass a fair budget.
