2016-2017 GENERAL FUND BUDGET

A motion was made by DeGusipe second by P Dunham to adopt the General Fund Budget for fiscal year beginning July 1, 2016 in the amount of \$51,016,740.00 as presented; and authorizes that the tax on real estate be levied at the rate of 14.935 mills which is an increase of 1.9262 mills or \$1.49 of each \$100.00 assessed evaluation of all property taxable for school purposes located within the School District. All Act 511 and other School Code Taxes will remain in effect at the same rate. All members present voting in favor of the motion.

Mrs. Swaney stated she voted yes with regrets.

President M Dunham announced we have furloughed, teaching staff and nonprofessional staff along with cutting programs and expenditure cuts in athletics and other areas. This board did everything possible not to raise taxes.

Mr. Bezjak asks the public not to blame the board or administration for the tax hike. Legislators in Harrisburg are ignorant of the fact they are to be funding education. Eighty-five percent of schools in Pennsylvania are being forced to raise taxes to maintain a viable school program. The inadequate school funding formula has to be changed. Administrators and this board have done their best to not raise taxes, put the blame where it belongs on our ineffective state legislators.

HOMESTEAD

A motion was made by Swaney second by DeGusipe to approve the Resolution authorizing the Homestead and Farmstead exclusion real estate assessment reduction for the Albert Gallatin Area School District's fiscal year beginning July 1, 2016, under the provisions of the Taxpayer Relief Act (Act 1, 2006), as presented.
